**DUTIES, TAXES AND OTHER PAYMENTS**  
**(EXEMPTION) (BARBADOS RALLY**  
**CLUB) (NO. 2) ORDER, 2011**

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Barbados Rally Club) (No. 2) Order, 2011*.

2. The Barbados Rally Club, a company continued under the *Companies Act*, is exempt from the payment of stamp duty in the sum of \$13 112.90, in respect of the importation of the motor vehicles listed in the *Schedule* for the purposes of the 2011 Rally Barbados Event which was held on the 29th May, 2011, 4th June, 2011 and 5th June, 2011 respectively.
